**Parent Responsibilities:**

**We, as parents, will support our children's learning in the following ways:**

- *Monitoring attendance.*
- *Making sure that homework is completed.*
- *Monitoring amount of television and electronic use by my children.*
- *Volunteering in my child's classroom.*
- *Participating, as appropriate, in decisions relating to my children's education.*
- *Promoting positive use of my child's extracurricular time.*
- *Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district received either by my child, by email, or by mail and responding, as appropriate.*
- *Serving, to the extent possible, on policy advisory groups, such as being the Title I, Part A parent representative on the school's School Improvement Team, the Title I Policy Advisory Committee, the District wide Improvement Team, the School Support Team or other school advisory or policy groups.*

**Student Responsibilities:**

**We, as students, will share the responsibility to improve our academic achievement and achieve the State's high standards. Specifically, we will:**

- *Do our homework every day and ask for help when needed.*
- *Read at least 15 minutes every day outside of school time.*
- *Practice math facts daily.*
- *Give our parents or the adult who is responsible for our welfare all notices and information received from school every day.*

**Bullhead City Middle School, Desert Valley, Diamondback, Fox Creek Junior High, and Sunrise will:**

1. *Involve parents in the planning, review, and improvement of the school's parental involvement agreement, in an organized, ongoing, and timely way.*
2. *Involve parents in the joint development of any school-wide program plan, in an organized, ongoing, and timely way.*
3. *Hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements, and the right of parents to be involved in Title I, Part A programs.
